Chaplain Rossetki, Protestant Chaplain was instantly KIA from a direct hit. Our immediate area was all under bombing. Hq Co had several cosualties right near Bn Cp. Cpl Englisher SWA and Clayton SWA. Sgt Floyd LWA. Also Sgt Meurer of Co D StA. 3rd Bn 119th Inf hit stiff resistance at line of departure. Regt'l directed lat Dn to attack due south and take the high ground east of Hebecraven in an attemp to flank the strongpoint. The Bn attacked in a column of companies with B leading followed C. Co A mounted on tanks of 743rd Tank Bn was to follow behind 120th Infantry and enter Hebercraven from the NW. Co B hit strong resistance east and NE of the town. Major Herlong ordered B Co to bupass resistance by going to the left then committed Co C on the right. Bn had captured approx 60 PW's and 1 officer, the remants of one Co, and were able to take the high ground east of Hebecraven about 2100 that evening. Our casualties were extremelz heavz. Captain Kores of the Mediccs was SWA: Sgt Nichols was KIA. The wounded were evacuated bz hand over a long rough terrain. Regt'1 CO ordered 1st Bn to enter and take the town from the east that night about 2350. Because of resistance on our left front, the Bn was unable to pivot and leave an exposed flank. The 2nd Bn 117th Infantry was brought up on our left flank. Major Herlong ordered Captain Simmons of Co A to enter Hebecraven from the NW being supported by the attached tanks of 743rd. Co A notified Bn at 0200 on morning of the 26th that they were in the town. Co C sent patrolsand contacted Co A.

Regiment ordered Bn to continue the attack south of Heberraven, with mission of seizing main road running west from Saint Lo. The Bn attacked with Co A leading followed bz C and B in reserve. Approximately one quarter of mile S of St Lo, heavy resistance was encountered. Hebecraven and vicinity was constantly under heavy arty fire. Co A was unable to advance having considerable casualties. Captain Simmons Commanding was LWA. Lt. Knowe assumed command. Co C was committed on Co A's exposed right flank. 3rd Bn Co K 119th Inf was committed on A CO's exposed left flank. making slow progress we broke thru at about 1400

wodnesday	July	د.	The Dn advanced rapidly meeting no resistance cut the highway leading W from St Lo, and went into defensive position on its objective. The CG of the 30th Inf Division complimented the Dn for its splendid work.
Thursday	July	27	We jumped off at 0800 again as the leading Bn, with mission of cutting the main road running SU from St Lo and defending the west side of the Vire River. We advanced rapidly with no resistance until almost on objective where we came under heavy mortar fire and small arms. Co B was leading Co C was committed on B's right. Co B was able to advance, outflanking the resistance in front of Co C. Ist Lt Pearson of Charlie was SWA and because of his inability at this time during this engagement, Captain Poinsett was relieved of his command of Co C. The Battalion took many prisoners, advanced, cut the road running SW from St Lo and was in defensive position along the Vire R. by 2000 that evening. The enemy could be seen east of the Vire withdrawing in disorder from pressure to their north.
Friday	July	28	We moved into rear assembly area, alerted for movement on 15 minute call. We reverted back to original corps at 1200. Co A received 5 replacements. Lt. Stahley reported to Co DModics got some men.
Saturday	July	29	At 0430 we received new attack order. The 119th Inf was to attack at 0800. At 0520 the Co's started to move to fwd assy area. At 0630 the CP was set up. Attack was met with stubborn resistance. We were suffering heavy casualties. Had Bn rear and Medical station in same building. Prisoners came in slowly. Cpl Chanbers of 1st Bn Hq Anti-tank SWA from 88 fire near CP. At 1825 we moved CP. We had about 55 wounded that day and several KIA's.

One plat of B and Anti-tank plat ordered out on Regt right flank to furnish security for Armd Arty 3rd Bn given orders to withdraw through the 1st Bn, 1st Bn to hold at all costs. Co C, attached to 3rd Bn, was working with 9 tanks, aiding 3rd Bn orderly withdrawal. Co B sent out patrols. Bn receives order at 1410 to attack with attachments - Co A 740 Tk Bn, Plat of 823 TD Bn. Attachments jumped off at 1500. Knocked out enemy tanks. We had one battle casualty and 6 NBI. We will attack in the morning. Climaxing the 3rd Bn was pushed back from high ground around Stoumont. Lst Bn held all ground. We have 2 Plats Co E attached.

Wednesday 20

Dec We attack at 0830, Pvt Wensing, Co B goes AWOL. Both Co A andB are moving slowly. Baker sent back one PW from the 2nd Regt, 1st SS Div (Adolph Hitler Co C taking out Jerry roadblock, knock out I tank. We are attached to the 18th Corps made up of Air Borne Units, notably the 82nd and 101st Div. At noon Co C was meeting resistance from both sides. Called for 1 belt. Crop 6 ordered A to push up on C's right flank, Co B to push up on the left. Co C calls for two belts. Dalton, Comdg A Co, wants tanks to follow him. Two C EM Kia. One friendly tank knocked out by mine. Rosse of Hq A & P platoon lost leg by mine. Likely move our CP to "Targan". At 1530 we are fighting close to Stoumont. We got regimental order at 1600 to continue the attack seize and defend Stoumont. defend in its zone and put out road blocks. 3rd Bn was to seize Stoumont in its zone, and the 2nd Bn establish positions around Targnon. We get 155 mm to use at our disposal. Capt Fell notifies us the lead tank is knocked out. At 1715 Crisis 6 tells us to hold un. set un defence --

1230 Co B was receiving a unterattack around the Chateau. One of their MG knocked out. Ask Culture for 1 Co to help and use as reserve. Able send one platoon to back Baker. All troops alerted. They call for more 30 Cal heavy MG ammo. Maj McGowan laerts Co F. We get report that Jerry has overrun the chateau, although we have some EM and 0 in a wing. Plat communication to Co B is cut off. We could hear Jerry on the phone. At 0200 we had another counterattack. This time they hit Co C. Lt Spraker WIA. We also had several EM wounded. They attacked again at 0400. The Chateau with Lt Anderson, Hendley and Heginbotham and several EM including Sgt Tate was definitely in Jerry hands. We had 4 tanks knocked out.

Thursday 21

Capt Fell reports he has 60 EM. Both B and C were Dec badly beat up. Widener and samll group were still holding out in the chateau. Baker estimates strength about 60. Up until 0920 we had 20 casualties. Co's reorganiying and will take Stoumont. At 1045 the Bn Liason brings down order. Arty will be fired in both towns from H to H plus 15. Everybody will jump at H hour not waiting for tanks. Infantry will use smke grenades, to screen advance in necessary. Engrs will be prepared to life mine fields. We are to organize defense of Stoumont as soon as possible. Early in the morning, Higgins Co A medic KIA. We will attack at 1245. Col H advises Crisis 6 the road is not clear of knocked out tanks. General Harrison and Col Sutherland visit CP. A Co jumped on time. Tanks moving slowly across open field. We are receiving Enemy mortar fire. We could hear some 20mm firing. Able calls for 4 belts. A Co's left unit is pinned down by MG fire. Likewise his right unit is also pinned down from Enemy MG cross fire. Cpat Fell at 1400 is committing his support platoon. They call for 2 belts. We are fighting in the chateau. Dalton has 6 EM wounded that they can't get to. Co C calls for grenades. We get report Jerry has a tank in rear of the Charteau. Both B and C call for more mortar armo. Crisis 6 advises Crop 6 the 2nd Bn will be pulled back and around to assist the 1st Bn. This will give depth to the 1st Bn. Advises Co A to groundhog in best available condition. All of Co Baker and Charlie EM who were fighting in the chateau get out safely. Co's all in all gained very little ground. Dig in approximately the same postions. We had definitely 15 KIA and 48 WIA. Had at least 50 MIA. M/R A 151, B 86, C 107, D 141, Hq 131.

22

General Harrison and Col Sutherland visit CP.
Crisis send 155 mm gun in immediate vicinity of our 'P and fire in town. TD also fire into Stoumont. Both B and C have cleaned out chateau. All Jerries have gone. We get orders to jump at 1320. We will move after the 3rd gets on obj. Take the town wit little difficulty. During the night Jerry dropped from planes supplies and gas for the cans. For the day we had six casualties. Late in the evening Lt Walters took a patrol and led Capt

chateau about 600 yards be ond the front lines. Evacuate wounded Americans, some aid men and also some Jerry prisoners.

Saturday 23

Dec We get orders to move on attack of La Gleire. 1st Bn to attack in its zone. Attack at 0830. 504th Paratroops continue to hold present postion on our right. At 0910 we had not met any resistance. we found many Jerry wounded at the cahteau and numerous dead Germans. The place was a ghastly mess expecially in the basement. Strengths of units: A 151, B 86, C 107, D 141, Hq 131. Attack progresses fair. Able calls for three belts. tank knocked out in La Gleige. Mine fields holding progress up. Co C in its present postion when they move they receive machine gun fire. Col H gives order at 1900. 2nd Bn will make jump for the town. Our mission is to clean out woods, get back half sector. We attack the hill south of La Gleize and prepare to continue on.

Sunday

24

Dec

2nd Bn has mission of taking the town. All direct fire weapons will lend support to the attack. At 0900 the 2nd Bn was in the town. We heard over Jerry radio they were trying to escape. Apparently this was true because the enemy had gone. Of course we recovered all our captured American personnel from the 3rd and 1st Bn. Found Lt. Hendley KIA. Lt Heginbotham and Lt Anderson were allright. although evacuated from concussion. Our Bn was sitting on hill overlooking the town. 1st Bn goes into the town. That day we received 84 replacements of which 16 went to Dog. 31 to Baker and 37 to Charlie. We found a tremendous amount of abandoned equipment. It was a costly blow to the SS Hitler Division. They were a pathetic sight as they had the wounded march down the road. Many had been wearing GI clothes which we removed. Bn strength was 716. All personnel from Baker Co captured in the chateau were retaken, although a few were evacuated. We found over 100 dead Jerries Maj McGowan was still missing. Col PIPER of the SS had taken him with him. We set up defense around La Gleize. A final showdown of Jerry equipment showed 28 tiger tanks, 70 half tracks. Complete list: M-4 6, M-5 15, M-6 7, half tracks 70, Assault guns 75mm, 2, 2 1/2 ton trucks 3, Red Cross Ambulance 1, German jeeps 4, 120 mm mortars 6, AT gun 88 1, 20mm 5, Armored Cars 8. self propelled howityer 170mm, 6, half track Red Cross 3, GI tracks 6, 2 1/2 ton trucks 1, Flak wagons 4.

Monday	25 Dec	We are sitting in defense around La Gleize. Co's had hot chow. Ordnance was to come around and pick up Jerry vehicles and tanks. Waiting orders. M/R A 146, B 142, C 139, D 154, Hq 133. We definitely had turkey for dinner. All during the day press people visited our CP, including Wes Gallager from AP. Also a photographer took some pictures and Lt Kerrick made a record for "Combat Diary". Sgt King, Co A receives his commission. Lt Brooks to be trfd to Co C. We send 2 jeep patrols at different hours to contact our 2nd Battalion. The 119th Inf, minus Crop, will move to vicinity of Custom.

The British will be on our left. Tentatively at 2200 the British Commandos will establish bridgehead then Lancasters will bomb WESEL following which they will drop approximately three divisions of air borne troops.

23 Hq 133, A 172, B 177, C 170 and D 142. Col attend final meeting with CO's at 0900. D day is 24 and H hour is 200. There will be 1 hour arty preparation. The 117th Inf on right atks and seizes obj within their zone. The 119th Inf atched Co C 743rd TK Bn and Co A 823rd TD and Co D, 18th Tank Bn supported by the 197th FA and reinforce elements of the 105th Engr Bn will force a crossing of the Rhine River in its yone at H hou on D day and will establish a bridgehead across river and seize Obj Patty, Hedy, Jo and Peg. 1st Bn will move by route indicated from present Assy area so as to reach fwd ass area, ie, Buderich at H plus 2 1/2 hours. At 2000 we got word that 1 officer and 5 EM would go to the states. Lt Bons was selected, also A Bogart, B Widenier C Villa, D Mouchon.

O730 through the LD and start for Jo and Hedy. At 0905 30 prisoners were taken. Fighting was stubborn, especially from mortar and arty. Lt Dimas acting at Ln with Beachmaster to Col Herlong was subjected to intense arty and mortar fire on the bank of the RHINE! Did an exceptionally good job. At 1500 they started a 30 minute preparation and will attack again, to take obj HEDY! At 1845 Co A and C were at the 2nd RR before Frederick Feld. Jerry tank was hitting us on both flanks. By 2000 we had cleared Heady. We had 3 KIA and 18 wounded in initial battle of the Rhine. Co B was attached to 3rd Battalion to take obj Peg. Today the 119th Infantry took over 300 prisoners.

Sunday

March

25

Co B working with 3rd Bn had little trouble cleaing out Peg. Co's A and C still getting PW's out of Frederich Feld. The 119th Inf was in division reserve, ready to be committied on either flank of the divison. Co strengths A 150, B 169, C 162, D 141, Hq 133. The officer and 5 EM leave for the states of 27 March. They are to get 45 days. Co C sends 1 platoon across canal LIPPE to clean out area. Get quota 12 EM for Paris. Col had to go to Crisis at 1420. We will protect the divison flank by taking obj HUBERT. Co B held up at 1830 at the LD by 20 mm fire. Co's start moving A on right and C along the Canal. A took 66 PW's. Bn CP located just outside Hunex. The 117th didn't go where they were supposed to. We had some casualties. Co C had 4 and D had one. We had two jeeps knocked out from Co D, setting off some ammunition. At 0200 Co's were still fighting. 2 EM KIA and Sgt Nichols as plat ldr was SWA. from 20 mm fire.

Monday

March

26

Co A 149, B 161, C 150, D 138 and Hq 133. At 0900 Co C was on phase line 7 meeting no resistance. Co A at 1230 was almost on obj Hubert. Co C had 3 MIA, 2 KIA and 6 WIa. At 1330 Co's were meeting enemy tanks and direct fire. Just from the town of Gahlen, a definite strongpoint. The town had scattered buildings. and were holding at all costs. I medic from C Co. Campbell, KIA. 3rd Battalion was being committed on right flank. At 1930 they were still receiving direct fire from the town. At 1330 Lt Walters was sent by the colonel to locate our adjacent unit and show them our right flank. Evidently he took a took a route that had not been swept of mines. Early the next morning the bodies of Lt Walters and the driver, Le Blanc, were disocvered KIA immediate. Co A had several casualties, 2 KIA including Sgt Fry. Co B hadl KIA.

Tuesday

March

27

Co A 141, B 147, C 138, D 137 and Hq 133.
During the morning Co A and B cleaned out the town. Co C was in the island. Our 2nd Bn was to take obj Mae.

Tuesday	March	27	Elements of 2nd Armd and 95th Div in vicinity Co's put out defensive positions. Co C stays on island. From G-2 notes in the attack of the 1st Bn of the 119th Inf towards its objective met stiff resistnace in the form of direct fire, arty fire and fire from AA guns. A group of 7 flak wagons were firing initially from edge of the wods. The resistance was broken by our attack and many flak wagons were destroyed. Our troops continued to advance while they met another enemy position. The enemy defense of the area was based on fire of small arms and automatic weapons, supported by arty and direct fire. Our troops finally penetrated the outskirts of Gahlen which was reduced, cleaned out on the 27th by the 1st and 3rd Battalions. Co's were situated in defense around Gahlen for the night.
Wednesday	Herch	28	Co C sends out patrol but meets no contact. At 1200 hours the city of Dorsten was taken Possibility that C and other units may hold their position. Today the first group of furlough me n to the states returned. Weisman of Co D must report back on the 5th of April for OCS. Men of the 119th Inf Officers are given the opportunity to transfer to the 106th Div with advance in grades but we find no candidates ecause they were badly mauled in the breakthrum at the Bulge.
Thursday	March	29	Co's still in same positions. Co C may move up into the town. We get word at 1430 that the 50th Div will revert back to 19th Corps. Col Herlong is going to the Riviers on 29th. Co C went to showers at Hunx.
Friday	March	30	We are now in corps reserve of the 16th corps. Battalion moves to Gahlen. Major Wayne assumes command of the Bn while Herlong is at the Riviera. Attends Unit VO meeting at Custom. Lt Tate returns to duty with Co B. Suddenly we are notified by Lt Capt Franklin to pick up 25 trucks at definite location. We officially go back to 19th corps.
Saturday	March	31	Passes scheduled for Kerkrade and Hericen are cnacelled. Lt Henderson of the 9th army historical section visits the CP. Officers and men get paid. Late at night we get further rush orders. At midnight we are aberted to move to corps flank. Kichens will move with

Sunday April At 1030 we stopped after traveling some 55 miles. Located in Soldendorf. This was south of Munster and north of Hamm. The Battalian had crossed the IP at Humix at 0417 and went to Sendenhorst. The 1st Battalion led the 119th column whose mission was to protect the flank of the corps with the rapid advance of the famous 2nd armored Division. At 1700 hours we are alerted to move again this time with mission of relieving CCA who were to go on. At 1930 orders were changed. Attached to CCA and would go to new ass area. We were working now with a combat command of 2nd Armd and would move out at H plus 42.

We stopped at 0800, after traveling 55 miles. April Londay Te are attached to CCA, 2nd Armd Division. On the trip 1 EM from Co A was KIA, accident when his rifle went off in the truck. Also 1 vehilce of Co D had 4 injured from an accident. At 1005 Major Wayne reports to Crisis. It seems that 2 battalions will be committed to clean out a pocket. Lt Dunn reports to our CP with the following instructions. We are to send 1 Co with Maj Owens of 1st Bn 66th Armd Regt. Our Unit minus Co C will be prepared to move immediately. Bn will move out at 1215. Move by truck some 4 mi to Assy area. Then move forward into positions. Will relieve elements of the 95th Inf Div of the 337th Inf. Move into postions at Oerlinghausen. Enemy had 20 mm and machine guns directed from high ground. At 1700 Co A and C were meeting stiff resistance. Jerry was using Panzerfaust. Sgt Goode and 2 EM wounded from bazooka fire. Both A and B are still fighting at the bend in the town. General Collier who commands CCA visited our CP. We are making every effort to clean it out, but it is a rugged process since there are many houses to be cleaned out. Send up TD's to blast a few houses. D had EM KIA from small arms. At 2100 CO A notifies Major Wayne the situation on his flank is serious. However Capt Dalton reported he could hold, especially with B watching the flank. He Co organized into small fighting units. They will protect any infiltration to our rear. At 2030 Co A called for a belt. We get 8 more prisoners. Co A pulls back its left flank a bit leaving a small gap. Major Wayne advises B to push over to the right to close the gap. Lt King platoon is being hit on all flanks. M/R Co A 140. B 147. D 133 and Ho 138. Co C came up at 0530 giving manuverability to our attack.

Tuesday

April

They continue fighting with tanks and also Major Wayne commits Co C. Working out plan to flank the town which was definitly an important village sitting between the hills and which prevented the armor from fanning out. This town of Oerlinghausen was large for a single Battalion to clean out and Jerry was using Panzerfaust to great extent practically as artillery. We were suffering several wounded Co A had one EM KIA: Major Wayne sends Lt Dimas to search for route to send the tanks. The S-2 took Cooperstein, Lord and Fleming with him. An hour later we had report the group were pinned down by MG fire. A detail under Capt Hubbard and Sgt Placko got the group out and Lt Dimas was seriously wounded by sniper in stomach and promptly evacuated. At 1530 the Co's started pushing again. We had then taken 48 Prisoners of War. By five thirty we had 90 prisoners. Lt Rich and Barker with their assault group had taken 20 PW'S. By 2100 Major Wayne reported to Crisis then under command of Col McCugh that the town was completely cleared. Total PW's taken in this all important fight was 275, and Major Wayne had done a fine job while the Battalion CO was on pass in Riviera.

Wednesday April 4

We get new orders: attached to TFR and will jump at 0800. Will move out in a column of Companies. We moved along with tanks and though we burned many houses met no organized enemy and kept going on. Took several Prisoners. Were located at Breitenheide, Germany. Had moved six miles east. At 1200 we got mission of taking Lemgo. Co's would ride tanks. Arrived at Arzon traveled 25 miles, got there at 2340. During the convoy a Jerry vehicle slipped into the column but Hq Co men spotted it and shot it up killing one and capturing four.

Thursday April 5

No changes in our M/R. At 0900 Co A on tanks moved out of Arzon. They were under TF Zion Major Wayne went up to the Weser river to make rcn. Co's alerted. The 1st and 2nd Bn may force a crossing. Co C was to send one plat to relieve a unit of Co E on high ground overlooking the river. Crisis notified us to send 6 EM back to states. Overman and Sparks Co B selected: Grenier of Co C: D sends Hall and Biller and Caballero of C went as compassion ate case. At 1430the bridge was almost complete. No arty fell in area and in fact people were at the site watching the show and found no en fire. The 82ns Engrs constructed the bridge. At 1520 Co A started crossing. Bn CP located at Ohr. We took obj without any trouble. Co C was sent with TF Zion to establish a roadblock west of our sector. We were alerted to move early in morning probaly to take Hameln, city famous for the Pied Piper legend.

We are alerted to move out early and pull in our 6 April Friday blocks. Co C again attached to TFZion. Notified that Lt Danner will go to school for refresher course for battlefield commission officers. Battalion was now located at Afferde. W were to be relieved by elements of the 117th Inf. go into an ass area and then take off again with TFR. Battalion at 1700 moved to Bessingen approx five miles east. We were to move at 0630 the following morning. We detrucked at Schulenberg and captured a bridg 7 Saturday April in tact. Co C was to hold the bridge and set up read blocks. We probably will have to take Sarstedt. Co A with tanks will try to clean up Sapstedt. Battalion alerted at 1300. One plat Co B and one plat of Light tanks of Co C had mission of cleaning out woods SW of Schulenberg and check a tremendous castle set off in the wod Co B then given mission of putting out blocks defending to the Northwest. Co A plus plat of med tanks and plat of TD's were in reserve for CCA not to be committed except under General Colliers orders. Battalion CP still located at Schulenberg. Our mesion was to maintain certain roadblosks and also to clean enemy from area between MLR and Immersets. On completion of mission were to reeassemble in vicinity of Schulenberg. in CCA reserve. No changes in M/R. Co C with two platoons was Sunday April 8 cleaning out woods. Colones Herlong returned frm Riviers. Co B pulls back to its original area. At 1600 Co A still with TF Zion is alerted. Co C took 99 prisoners and capturd a large warehouse full of Whermach equipment. Col H and command group move out at 2200. Later Co B took 145 prisoners out of woods. Cleaned out Harsum. Battalion rear now located in same town. Monday April 9 At 0920 Col Herlong goes to receive order. TFR will follow TFB on order over white and red axis and seize obj 6, 10 and 13, We will be physically relieved by TFB but orders are changed and the entire Battalion moves back to Schlenberg. Now w understand that the 30th Div will be on 2nd Arma left and also 83rd Div on flank. We are alerted to go to ass area in vicinity of Grosdungen. At 2200 Col Herlong goes to Crisis . Tonite 1 plat Co C and plat of TD's go on roadblock. Tuesday April 10 We cross IP at 0930 destination unknown. Travelt to Lesese approximately 26 miles. Co B takes 161 prisoners out of woods and a Lt Colonel. A and C are now under TF Zion. Co B located in Rappner, A and C in Lebenstedt. Battalion rear in Lesee. Co A had a few casualties. Wednesday April 11 At 0100 hours Col receives new attack order. Co's will attack at 0630 and take Immerdorf location of the famous
